

## VISA TYPES AND REQUIREMENTS

FOR SHORT TERM/NON-IMMIGRANT VISA – UP TO 90-DAY STAY

PROCESSING TIME: 3 to 7 WORKING DAYS\*

### Principal documents

- Visa application duly filled out, dated and signed (available on the Embassy’s website or upon request)
- One (01) recent passport photo (2 x 2 inches)
- Original passport of the applicant (no photocopy)
- A copy of the round trip ticket or itinerary confirmation bearing the name of the applicant
- Payment of the visa fee (Cash, Bank Transfer)\*
- A yellow fever vaccination certificate is required if the traveller stayed in an affected area six (06) days prior to the trip

**IMPORTANT: APPLICANTS MUST NOT PROCEED TO PAYMENT UNTIL PROMPTED TO DO SO**
