

ENTRY VISA FOR A LONG TERM STAY (beyond 90 days) - ONE MONTH TRANSFORMABLE AND EXTENDABLE TO A LONG TERM VISA
Please note that all the Entry visas listed here below are to be transformed and finalized into a Long term visa only in Madagascar
THE PROCESSING TIME WILL TAKE 3 to 7 WORKING DAYS*

Important note:

- The Embassy of Madagascar in London is entitled to issue "One month transformable and extendable to a long term visas» to residents of the following countries: United Kingdom and Northern Ireland, Ireland, Finland, Norway, Sweden.
- Residents of countries in which Madagascar does not have a Diplomatic and/or Consular Representation must apply online at www.evisa.diplomatie.gov.mg for an "AUTHORISATION FOR BOARDING" (Accord d'embarquement), valid for 72 hours from arrival in Madagascar. Holders of an 'Authorisation for Boarding" must then go to the Ministry of Foreign Affairs within 72 hours upon their arrival to affix the extendable and convertible visa on their passport.

Compulsory steps to be completed to stay in Madagascar for more than 90 days:

STEP 1: Application for a "One month transformable and extendable to a long term visa" (transformable visa) at the Malagasy Embassy.

STEP 2: Once in Madagascar, the holder of a transformable visa has one (01) month to transform his visa into a long stay visa and apply for a resident card at the Ministry of the Interior, Immigration and Emigration Service. The original version of the documents presented at the Embassy will be required.

Principal documents:

- Visa application form duly filled in, dated and signed (form to be downloaded on www.mdg-london.org or upon request).
- One (01) recent passport photo (2 x 2 inches)
- Original passport of the applicant (no photocopy)
- A copy of the round trip ticket or itinerary confirmation bearing the name of the applicant
- Payment of the Entry visa fee. Method of payment: cash or bank transfer*
- A yellow fever vaccination certificate is required if the traveler stayed in an affected area six (06) days prior to the trip
- Police certificate (less than 6 months old) from the applicant's residence local authority
- Invitation certificate and attestation of support or a copy of a house or apartment lease agreement
- Copy of the Malagasy National Identity Card or Resident Card of the host
- Proof of residence of the host

*** IMPORTANT: APPLICANTS MUST NOT PROCEED TO PAYMENT UNTIL PROMPTED TO DO SO**
